1. Margin is calculated progressively, basing on the amount of lots, for example:
client: standard

instrument: EURUSD

lot value: 100 000 EUR

order size: 600 lots

order side: buy

market price: 1.08658

The margin value is calculated as follows:

2. The value of calculated Margin for hedge positions will not be collected. In case of Meta Trader demo the value of calculated Margin for hedge positions is an average of the values of calculated Margins of such positions.

3. If the Equity to Margin percentage ratio (the so-called Margin Level) is below 100% and there is at least one Open Position in the Client's Account, conclusion only of a Reverse Transaction is possible.

4. If there is a justified suspicion that multiple accounts are managed by one person or the group of persons connected with each other in order to avoid margin increase, they will be aggregated to the one trading account and they will have Margin requirements corresponding to the mentioned group or each of this account might be terminated.
